



**Circular Letter No. 2/2024
dated 17 September 2024
issued by the Chancellor of the Warsaw University of Life Sciences**

on the introduction of “Accommodation fees in SGGW student dormitories, effective from 1 October 2024”

Pursuant to § 41(1), (7)(1) and (8)(7) of the Statutes of the Warsaw University of Life Sciences, in conjunction with Article 79(2)(6) of the Act of 20 July 2018. Law on Higher Education and Science (i.e. Journal of Laws of 2023, item 742, as amended) and § 6(2) 2 of the Regulations of the student dormitory of the Warsaw University of Life Sciences, constituting an appendix to Ordinance No. 44 of the Rector of the Warsaw University of Life Sciences of 18 September 2019, on the introduction of the Regulations of the student dormitory of the Warsaw University of Life Sciences, the following is hereby adopted:

§ 1

The “Accommodation fees in SGGW student dormitories effective from 1 October 2024” specified in the appendix to this circular letter shall be introduced on 1 October 2024.

§ 2

The implementation of the provisions of this circular letter is entrusted to the Head of the SGGW Dorm and Canteen Administration Office.

§ 3

The supervision of the implementation of the provisions of this circular letter shall be entrusted to the Vice-Chancellor - Economic Director, and the Bursar, in accordance with their respective scopes of activity.

§4

On 30 September 2024, the Circular Letter No. 1/2023 of the Chancellor of the Warsaw University of Life Sciences dated 1 September 2023, on the introduction of “Accommodation fees in SGGW student dormitories, effective from 1 October 2023.”

§ 5

The circular letter shall enter into force on the date of its signing.
