



**Circular Letter No. 8/2024
of the Rector of the Warsaw University of Life Sciences - SGGW
dated 17 September 2024**

on the introduction of “Accommodation Fees for Employees, Participants of Doctoral Studies and the SGGW Doctoral School in the IKAR and KROKUS dormitories and the EDEN Student dormitory (assigned by the Rector’s Housing Committee) effective from 1 October 2024.”

Acting pursuant to § 20(4) and (5)(12) of the Statute of the Warsaw University of Life Sciences in connection with § 7(2) of the Regulations for the allocation of places in the IKAR and KROKUS dormitories and the EDEN dormitory for SGGW employees and doctoral students, and persons undertaking internships at SGGW, constituting Appendix No. 1 to Ordinance No. 72 of the Rector of SGGW dated 26 June 2024, it is hereby established as follows:

§1

As of 1 October 2024, the “Accommodation fees for employees, participants of Doctoral Studies and the SGGW Doctoral School in the IKAR and KROKUS and EDEN dormitories (assigned by the Rector’s Housing Committee) effective from 1 October 2024” shall be introduced, as specified in the appendix hereto.

§2

Implementation of the provisions of this circular shall be entrusted to the Head of the Dorms and Canteens Administration Office.

§3

The supervision of the implementation of the provisions of this circular letter shall be entrusted to the Vice-Chancellor - Economic Director, and the Bursar, within their respective scopes of activity.

§4

As of 30 September 2024, Circular Letter No. 6/2023 of the Rector of SGGW dated 29 August 2023, on the introduction of “Accommodation fees for employees and participants of Doctoral Studies and the SGGW Doctoral School in the IKAR and KROKUS dormitories and the EDEN dormitory (assigned by the Rector’s Housing Committee) effective from 1 October 2023” shall be repealed.

§5

This circular letter comes into force on the date of its signing.
